To meet the objectives and challenges presented, Winning focused on two essential activities:

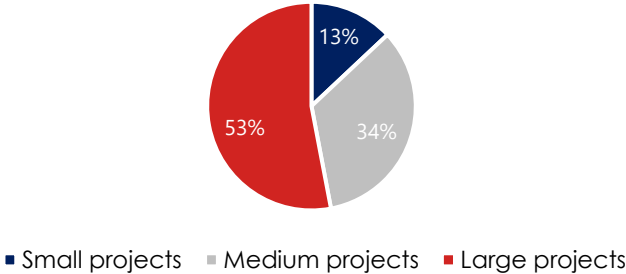
- **Project Management Assessment:** Assessed the ongoing projects, organizational processes and project management methodology , as well as the project managers' skills;

- **Implementation plan:** Developed an action plan that treated the causes of the main problems, guiding the company towards organizational excellence and increasing the knowledge in project management.

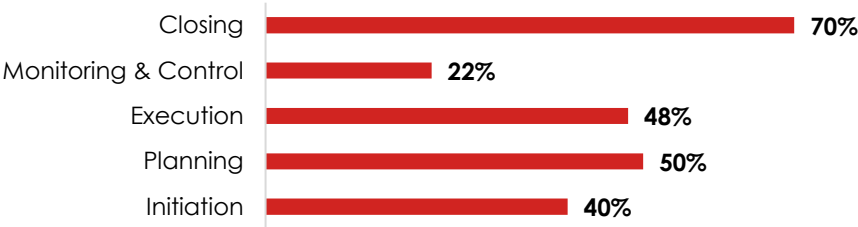
3 Impact
